

**United Way of Volusia-Flagler Counties
Car Giveaway
Official Rules**

ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Eligibility. Subject to the additional limitations set forth below, the United Way of Volusia-Flagler Counties Car Giveaway (the "Giveaway") is open only to residents of Volusia and Flagler Counties who are 18 years of age or older as of the date of entry. The Giveaway is not open to the employees of Jon Hall Chevrolet, the United Way of Volusia-Flagler Counties, or to the employees of any other company or organization that is involved in the sponsorship, promotion, administration or fulfillment of the Giveaway, or to the family members of, or any persons domiciled with, any of the foregoing employees. The Giveaway will begin July 1, 2011 and end at approximately 5 pm on March 30, 2012 (the "Giveaway Period").

2. How to Enter. No purchase, payment or donation is necessary to enter or to win. A purchase, payment or donation will not improve your chances of winning. All donations are strictly voluntary. Eligible participants can obtain one (1) entry for the Giveaway drawing by making a donation to the United Way of Volusia-Flagler Counties during the Giveaway Period. Only one (1) entry per person, regardless of the method of entry. Eligible participants can also obtain one (1) free entry for the Giveaway Drawing by visiting the United Way of Volusia-Flagler Counties office as explained below. There are a total of four (4) ways to enter and participate in the Giveaway during the Giveaway Period:

First, you can enter the Giveaway by making a suggested minimum donation of \$150.00 (payable by check, cash or credit card) to the United Way of Volusia-Flagler Counties at the office of the United Way of Volusia-Flagler Counties located at 3747 W. International Speedway Blvd., Daytona Beach, FL 32124 during the business hours of 9:30 am through 4:00 pm, Monday through Friday.

Second, any employee of any company in Volusia or Flagler Counties that has or will complete a pledge card during an employee campaign during the Giveaway period will automatically be entered to win. The suggested minimum donation is \$150 or two (2) hours of pay per pay period for the benefit of the United Way of Volusia-Flagler Counties.

Third, you can enter the Giveaway by visiting the website, www.unitedwayvfc.org, and making a suggested minimum donation of at least \$150.00 online (using your credit card) and by following all of the instructions for submitting an electronic entry.

Fourth, you can enter the Giveaway for free without making a donation to the United Way of Volusia-Flagler Counties by visiting the principal place of business of the United Way of Volusia-Flagler Counties, located at 3747 W. International Speedway Blvd., Daytona Beach, FL 32124, between 9:30 am and 4:00 pm, Monday through Friday, and requesting one (1) entry per person. Complete the entry form and return it to the designated representative of the United Way of Volusia-

Flagler Counties who will be identified to you when you visit the United Way of Volusia-Flagler Counties office at the address listed herein.

All valid entries will have the same chance of winning regardless of whether they are obtained for free or by making a donation to the United Way of Volusia-Flagler Counties. Regardless of the entry method(s) used, only one (1) entry per person will be accepted. Neither Jon Hall Chevrolet nor the United Way of Volusia-Flagler Counties shall be responsible for any incomplete, lost, late, stolen, misdirected, illegible, garbled or unintelligible entries, or failure to receive entries due to shipping or handling errors or technical problems or transmission failures of any kind, including, without limitation, the malfunctioning of any network, hardware or software. Any questions regarding the number or validity of entries submitted shall be determined by the United Way of Volusia-Flagler Counties in its sole discretion and the United Way of Volusia-Flagler Counties reserves the right to disqualify any persons who tamper with or abuse any aspect of the Giveaway. All entries become the property of the United Way of Volusia-Flagler Counties and none will be returned. In no event shall the United Way of Volusia-Flagler Counties be responsible for awarding more than one (1) prize vehicle in the Giveaway.

3. Prize and Odds. At the close of the Giveaway, thirty (30) finalists will be randomly selected in a drawing to be conducted by the Executive Director of the United Way of Volusia-Flagler Counties. The finalists will then be invited to attend the United Way's Campaign Finale which will be held no later than May 15, 2012. During the Finale one winner will be randomly selected in the final drawing . The winner need not be present to win.

One (1) winner will receive a 2012 Chevrolet Sonic -4 door sedan (1LS 1JU69) with a verifiable retail value of \$14,495. The prize vehicle is non-assignable and non-transferable. No substitution by winner or cash equivalent is permitted. Should the prize vehicle described herein become unavailable for any reason, Jon Hall Chevrolet and the United Way of Volusia-Flagler Counties have the right to substitute a prize of equal or greater value. By entering, participants agree that the prize vehicle may be driven for promotional purposes and may have minimal mileage on the odometer at the time of delivery. Winner agrees to accept the prize vehicle "as is" at the time of delivery subject to the remaining factory warranty coverage. Winner is solely responsible for all applicable taxes on the prize vehicle and for all license, insurance, title and registration fees associated with assuming ownership of the prize. Winner will be issued an IRS Tax Form 1099.

4. Winner Notification and Prize Delivery. Winner will be announced at the United Way Campaign Finale. In the event Winner is not present at the United Way Finale, Winner will be notified by telephone and/or mail. Winner will be required to complete and return an Affidavit of Eligibility and Liability and Publicity Release within ten (10) days of receipt, as a condition of receiving the prize. Failure to timely complete, sign and return the affidavit and release, or to comply with any term or condition of these Official Rules, will result in Winner's disqualification and the forfeiture of his/her interest in the prize. Winner may waive his/her right to receive the prize. If waived or forfeited, the prize will be awarded to a substitute winner selected in a random drawing from among all remaining eligible entries. By entering the Giveaway, participants agree to release Jon Hall Chevrolet and the United Way of Volusia-Flagler Counties, and all other companies and organizations involved in the Giveaway and all of their respective affiliated companies, officers, agents, employees and volunteers for any liability whatsoever for claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Giveaway or the acceptance, possession, use or misuse of any prize or travel to or from any Giveaway-related event or activity.
