Dear Grant Applicant:

The United Way of Volusia-Flagler Counties Women United-Flagler Chapter is pleased to offer small grants to 501c3 organizations that serve women and children in Flagler County. The organization does not need to be a United Way agency to apply for and receive funds.

### **Program Areas and Funding Guidelines**

We support organizations that share our passion to serve women and children in Flagler County. Each year our fund priorities are evaluated and may change. We are currently focusing on grants to programs targeted to assist women and children. The typical grant size ranges from \$200 to \$1,000. The specific grant award will be based on the fit of the requester and the funding ability of Women United Flagler at the time of the proposal. Organizations may only apply for funding once per 12 month year.

### **The Types of Grants We Fund**

In general, UWVF-Women United Flagler grants are limited to programs and/or initiatives that provide direct support to women and children in Flagler County.

### **What We Do Not Fund**

Please note below the types of grants we do not fund. Letters of inquiry regarding those types of projects are immediately declined so we discourage submissions of proposals in these categories.

The UWVF-Women United Flagler does not fund:

- Requests from individuals, political, social, or fraternal organizations.
- We also do not serve programs that target individuals from outside of Flagler County.
- We do not provide loans, start-up expenses or seed capital funding for private businesses or scholarships requested by individuals.

The UWVF-Women United Flagler does not fund the following:

- Organizations that discriminate on the basis of race, creed, gender, national origin, age, disability or sexual orientation in policy or in practice;
- Programs in furtherance of sectarian religious activities, impermissible lobbying, legislative or political activities.

### **Our Application Process**

Grants are accepted year round and reviewed/approved quarterly. One grant may be awarded per project within a 12 month period. Applicants are usually processed within 30 days of receipt. Complete and return application to:
