A Message from our President:

Transition. That is probably the best word that I can use to describe our United Way's progress over the last year. Yet, through all of the transition that our team and our community has experienced, we have risen to the challenge of ensuring top-notch service and excellence at the United Way of Volusia-Flagler Counties.

Most notably, our community and team responded to the unexpected passing of our President and CEO, Dennis Burns, in February 2019. On behalf of our entire team, we would like to say thank you to those who expressed their condolences and support; it was incredibly encouraging to see the outpouring of love from our friends and business associates.

We began the 2018-2019 fiscal year with a lot of sparkle, thanks to both Women United groups' Power of the Purse events. In all, over 700 women attended the events, which raised \$75,396 in support of local programs assisting women and children. Next, we kept 30 volunteers busy throughout the campaign season with nearly 380 presentations at local businesses, raising over \$2.2 million! Our Generation IMPACT group also launched their inaugural Social Innovation Fund pitch competition that supported four innovative projects from Flagler Palm Coast High School students. It was so encouraging to see the thoughtfulness, professionalism, and inspiration behind the students' plans to make a better tomorrow.

Our internal programs continued to meet the needs of local families. Our Help Me Grow Care Coordination team, for instance, assisted the grandparents of a 2 year old by providing a free developmental screening that resulted in a referral to Early Steps. Not only do the caregivers appreciate the referral, but also the care taken by our team to ensure that the family has access to resources throughout the process.

Whether it's through our Community Impact funding, 2-1-1, ReadingPals, Help Me Grow, or our Campaign for Working Families, United Way of Volusia-Flagler Counties is fighting for every person in every community.







AFFINITY GROUPS



United Way's Generation IMPACT affinity group is a group of young professionals who are dedicated to Innovating Modern Philanthropy and Community Transformation (IMPACT) in Volusia and Flagler counties.

This year, members of Generation IMPACT oversaw the inaugural Social Innovation Fund mini grant process, awarding **\$9,500** to four projects created by students from Flagler Palm Coast High School.

The winning projects included:

- **Juuls are for Fuuls** a project that provides teens and children with "factually accurate information about the harmful effects of e-cigarettes"
- **Project L.E.A.D. Children** an annual Child Fair that connects low-income families with infants and toddlers to early childhood development resources
- **FPC Bulldog Patrol** a proactive school safety initiative that incorporates safety baskets, videos, faculty training, drones, and K-9 patrol into FPC's emergency procedures
- **Root to Rise** a project that introduces mindfulness interventions to the classroom as a means of improving student success and mental health













- Women United Volusia hosted their 15th annual Power of the Purse, which saw a sold-out crowd of more than 600. Proceeds from the event allowed the group to grant \$58,896 to 20 programs serving women and children in Volusia County.
- Women United Volusia members collected and donated more than 1,000 pairs of gently used shoes to local programs serving women and children.
- Women United Flagler hosted their 10th annual Power of the Purse, where
 Joanne Tavzel was named Woman of the Year.
- Women United Flagler distributed **\$16,500** to **8** programs serving women and children in Flagler County, as well as two **\$1,000** scholarships to graduating FPC and Matanzas students.
- Members of Women United Flagler donated over 11,000 lbs of food through their Chicks with Cans initiative.


